This letter is a final response to your requests for information pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, related to the FOIA requests at issue in *National Student Legal Defense Network v. U.S. Department of Education*, 22-cv-3469. Your requests were forwarded to the appropriate offices that may have documents responsive to your request. Those offices have completed their searches for the following FOIA requests: 22-01567-F, 22-02544-F, 22-02687-F, 22-03122-F, 22-03292-F, 22-03608-F, 22-02589-F, 22-02690-F, 22-03124-F, 22-03294-F, 22-03610-F, 23-00059-F, 22-02143-F, 22-02545-F, 22-02688-F, 22-03125-F, 22-03296-F, 22-03612-F, 23-00060-F, and 21-02640-F.

In requests 22-01567-F, 22-02544-F, 22-02687-F, 22-03122-F, 22-03292-F, and 22-03608-F, you requested "a complete listing of all institutions that have been recertified as eligible to participate in Title IV, HEA programs" for specified time frames.

The Department has processed 643 pages of records responsive to your requests. However, certain information has been withheld pursuant to FOIA Exemptions 4 and 6 specified below:

- Records or portions of records relating to commercial or financial information that is privileged or confidential are exempt from disclosure pursuant to 5 U.S.C. § 552(b)(4). Disclosure of this information would constitute a clearly unwarranted invasion of privacy.
- Records or portions of records relating to personal information are exempt from disclosure pursuant to 5 U.S.C. § 552(b)(6). Disclosure of this information would constitute a clearly unwarranted invasion of personal privacy.
